# The President Speaks...

What an exciting year this has been so far. Our new board members hit the ground running and have been very active and willing to help with energy, time and ideas. That inspires and reenergizes those of us who have been members for up to 8 years.



I want to thank all of you who turned in your forms and provided your input concerning four different issues the board was considering. Your comments were very informative and have helped us as we move forward. The ball separators between court 7 and 8 had a lot of positive input as well as a few negative comments. We are moving forward to put permanent netting on the poles and to add ball screens between courts 9 and 10. The cost is higher than originally thought and there are a couple of technical difficulties on implementation of netting on the back courts.

The board recommended that a meeting be held for a forum type discussion on the league issue of adding a third "A" team from January through mid April. This meeting will be held on May 9 at 7:00pm in the BTC clubhouse. I think it is important for all interested parties to be there so that meaningful discussion can take place with all viewpoints in the same room at the same time. It might take more than one meeting to come to a conclusion, but I know that we can do it. We are all interested in playing competitive tennis, in supporting each other as we improve our games, in looking at the needs of all our members and in the total support of the sport we all love.

We have several items on our agenda that need money and our budget is limited. The board voted to purchase a color laser printer for Colleen to increase her abilities and maximize her efficiency. A new reservation desk was installed that is longer and much more attractive. New flower pots were added to our front entrance. We have also approved resurfacing the floor in the men's restroom and are awaiting bids. A new cover will be purchased for the pad in the women's restroom and will have a zipper to allow for easy cleaning. We have voted to purchase a Marker Board that would be placed in the center of the walkway between courts 8 and 9 and have obtained city approval. This would allow us to keep members informed of upcoming events in a timely manner without having to use paper banners.

The bleachers between courts 6 and 7 have been removed and given back to the city. We tried to put them outside of courts 1 and 11 to allow better tournament viewing at that end of the courts. This turned out to be too costly, and would have required ADA access which would have been impossible to accomplish. We felt that the bleachers could be put to better use in another facility in the city. Benches will be added to courts 6 and 7.

Our stadium will be getting a facelift from the company that resur-

## Tennis Tip From Mimi

Are you having problems hitting your serve over the net? If so, you might be bringing your tossing arm down too soon. When serving, your body needs to be in a tall upright position upon impact of the ball. After the toss, your tossing arm must remain up as long as possible until you hit the ball. If you bring your tossing arm down too soon, your body will become off balance and gravity will pull your body downward. If your body is falling downward, so will your serve, and thus the serve goes in to the net. Keeping your tossing arm up will allow you the ability to reach up on the serve and keep your body balanced correctly.



# MARION HARLAN MEMBER PROFILE

Marion Harlan joined BTC in 1990 after moving to San Diego from Tucson. She wanted to give her loving husband Gale a special present for his birthday so she signed them both up to become members. For years, Marion enjoyed the great game of tennis as a social and competitive player, even serving as captain of the BB Team.

In 2004, Marian began experiencing back pain. For those who love the game of tennis, pain is a challenge, yet no reason to stop playing. She tried therapy, but no relief could be found. Her doctor ordered an MRI. After the results came in, the doctor wanted to see Marian immediately, which in her mind, was “not a good sign.” The doctor informed her that the entire cavity was a tumor. Marian elected to undergo chemotherapy and radiation in hope of eradicating the tumor. She continued to play tennis during this time period despite treatments.

In 2006 the tumor grew and the pain worsened. In her words, “I never had a choice,” as the doctor recommended surgery to remove her entire leg, hip and pelvis. The 3 1/2 hour surgery, called a hemipelvectomy rattled the minds of family and friends, yet Marian maintained an inner faith and confidence in her plight. “I can't say it wasn't frightening,” she



said, “but I never cried. I was just hoping to wake up after the surgery.”

Marian came through the surgery well with the support of a great team of doctors, family, friends and a “very handsome anesthesiologist!” To add on to a famous phrase from Michael Jordan, Marian loudly proclaimed, “I no longer have a leg, but I'M BACK!!! She was recently fitted for a prosthesis and, in keeping with the great sense of humor that helped her through this

trauma, Marian says, “I keep my leg in the closet now.”

Nowadays, Marian maintains a busy lifestyle with a positive upbeat attitude. She does needlepoint and knitting in her free time, in addition to reading trashy novels and spy stories. She still comes out to BTC to watch her loving husband Gale play tennis and to play cards in the clubhouse. Gale and Marian continue to travel on a regular basis, yet only in the United States because the accommodations for the handicapped are so much better. Gale summarizes what so many people say about Marian. “She's an inspiration.”

Marian is making the most of the situation by staying busy and enjoying life. “I'm just happy to be able to do what I can,” she says as she wheels off to get ready for a trip to Texas.
